**Subsequently it is informed of the decisive causes of the detention deles/delas and of the rights that attend it, of conformity with that prepared in the Art. 520 of L. E. Crim., consistent in:-----**

- a) Correct to continue declaring silent if he/she doesn't want, for not to answer some or some questions that they are formulated, or to only manifest that he/she declared before the judge.-----
- b) Correct it not declaring against himself and for culprit not to be admitted.-----
- c) Correct to designate the lawyer and to ask the presence deles/delas so that this he/she attends the diligences policeman and judicial of declaration and it intervenes in the whole identity recognition that is object. If the detento doesn't designate the lawyer that you will proceed to the commitment of occupation of him.-----  
--Nevertheless the detento or prisoner, he/she can give the Well educated obligatory frequency if the detention deles/delas the fuere for susceptible facts of being exclusively tipificados, as Crimes Against the Safety in the Traffic.-----
- d) Correct to that he/she it dresses in the relative's knowledge or person that he/she wants, the fact of the detention and place of the custody in that he/she is in every moment. The foreigners will be entitled that the previous circumstances communicate to the consular office of the country deles/delas.-----
- e) Correct to be attended gratuitously for a he/she he/she interprets when he/she is a foreigner that doesn't understand or the Castilian doesn't speak.-----
- f) Right to be recognized by the forensic doctor or legal substitute and, in their defect, goes that of the institution in that he/she i or it goes any other clerk of the state or of other public administrations.-----
