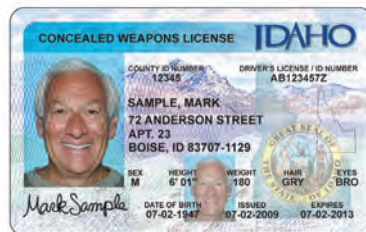

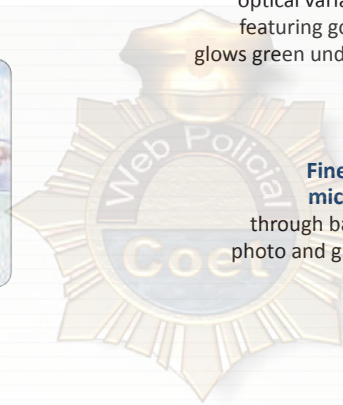

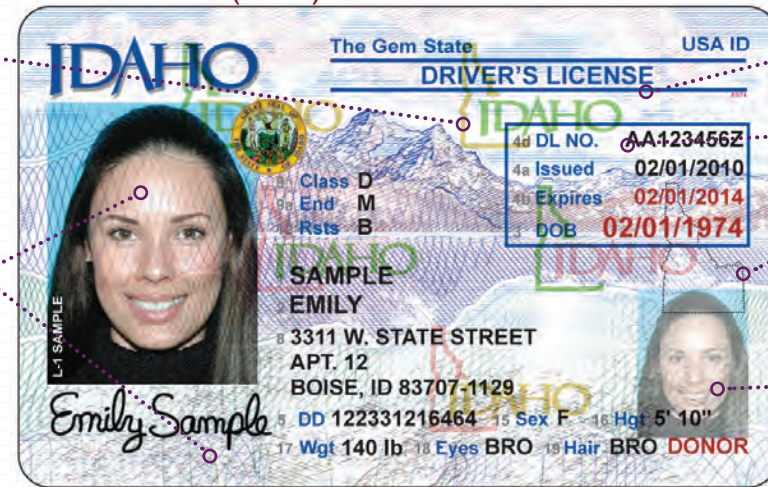
New look and enhanced security features

- **Color-coded header**
(shown: blue for Class D)

- **Key information**

- **Laser-perforated** pattern reveals the shape of Idaho when held to the light

All cards for minors are vertical

A green border around key information indicates “under 18,” a red box indicates “under 21”

These quick-reference tools help retailers and law enforcement with age identification

Reverse side of a card

- Barcode containing a manufacturing inventory number

- 2-D barcode containing the same information printed on the front of the card

- Laser-perforated pattern of Idaho

Temporary document printed on security paper

A temporary driver's license or identification card will be issued to use for identification and driving purposes until the plastic card is mailed within about 10 business days.

The temporary document contains a photo and all of the information that is contained on the plastic card, including the machine readable barcode.

It is printed on security paper, which contains ultra-violet (UV) fibers throughout. These fibers can be easily detected under a UV light source. The paper's reverse side features the Idaho state seal, and is color-washed with thermochromatic ink that temporarily turns white when warmed by the touch.

When the plastic card arrives in the mail, the temporary document should be destroyed.

Idaho's new driver's licenses and ID cards

Idaho driver's licenses and identification (ID) cards are getting a new look and state-of-the-art security features, all designed to avert counterfeiting and reducing the risk of identity theft and fraud.

The cards will also be produced in a new way.

Idaho is changing from an “over-the-counter” system to a “central issuance” system. Applicants leave the county driver licensing office with a temporary card, valid for 30 days. This temporary card is printed on special security paper with a black and white digital image.

The new plastic cards are produced at a secure, central facility and mailed to the customer within

about 10 business days. The card is mailed in an unmarked envelope, much the same way credit cards or passports are mailed.

Previously issued Idaho licenses and IDs remain valid until their expiration date.

Central issuance will result in system efficiencies and cost savings compared to issuing cards

over-the-counter. There is no additional cost to customers.

The new cards are made from a more durable plastic than was previously available. And, the format and production process follows recommended best practices.

What to expect

- There will be a change in the way licenses and ID cards look and the way they are produced.
- When applying for a driver's license or ID card, you will receive a temporary paper document issued for driving and identity purposes until the permanent card arrives in the mail.
- The temporary document includes your photo and the same information included on the permanent card.
- The new card is mailed within about 10 business days. It will be important to provide a correct mailing address.
- Current Idaho licenses and ID cards remain valid until it is time to renew.

All Idaho driver's licenses, ID cards and permits have a new look.
New, sophisticated security features are incorporated into the new cards.
Not all security features are evident.
